

## 1. INTRODUCTION

- i. The terms and conditions stated herein ("T&C") shall govern the Kaotim x Lim Tayar ("Promotion") organised by Syarikat Takaful Malaysia Am Berhad [Company No. 201701032316 (1246486-D)] (hereinafter collectively referred to as "Takaful Malaysia") in collaboration with C.K.L. Group (M) Sdn. Bhd. [Company No. 199101000014 (210324-M)] (hereinafter collectively referred as "Lim Tayar").

## 2. PROMOTION PERIOD

- i. This Promotion commences on 9 February 2026 at 12:00 AM Malaysia Time ("MYT") and ends on 30 April 2026 at 11:59 PM MYT ("Promotion Period").
- ii. Participation received outside the Promotion Period shall be disqualified and deemed ineligible for consideration for the Promotion (as defined below).

## 3. ELIGIBILITY

- i. This Promotion is open to all Lim Tayar customers who possess an active Kaotim Car certificate within the promotion period ("Customer").

## 4. PROMOTION MECHANICS

- i. The customer needs to spend a minimum of RM500 in a single receipt at "Lim Tayar" stores and will receive an RM50 instant rebate (the "Rebate") on the total receipt upon showing an active Kaotim Car certificate.
